# The Greenbook Project

The Greenbook Project is a federal initiative designed to bring together the court system, child protective services and domestic violence agencies to better address the needs of families when there is the co-occurrence of domestic violence and child abuse and neglect. Grafton County is among six demonstration sites in the country selected to participate in the five year project. Greenbook is the nickname for the National Council of Juvenile and Family Court Judges' publication, *Effective Intervention in Domestic Violence & Child Maltreatment Cases: Guidelines for Policy and Practice.* The publication and more information about the Project are available at www.thegreenbook.info.

### Interim Evaluation Report

### **Key Findings**

The report on DCYF files presents data on 2001 and 2003 cases. Findings from 2003 are summarized and compared to findings from 2001 cases.

The following provides some, but not all, of the key findings in the report. These are selected findings and much more information that puts all findings into context is contained in the full report:

\*In 2001 and 2003,

domestic violence was present in roughly one third of the founded cases of abuse and/or neglect.

\*Almost all 2001 and 2003 court-involved cooccurrence cases involved some type of neglect of a child.

\*The adult victim of domestic violence was identified as the perpetrator of abuse and/or neglect in close to two-thirds of the cooccurrence cases in 2001 and 2003.

\*Parental substance abuse was evident in nearly half of the 2003 cooccurrence cases.

\*There was a notable increase in the percentage of initial referrals (intake summaries) that referenced domestic violence in 2003 compared to 2001.

\*A higher percentage of

2003 cases included documented evidence of screening for domestic violence.

\*A higher percentage of 2003 cases included documented evidence that domestic violence victims were referred to crisis centers.

\*A higher percentage of 2003 cases included documented evidence that domestic violence perpetrators were referred to Batterer Intervention Programs.

\*A lower percentage of the 2003 co-occurrence cases resulted in out of home placements for child abuse/neglect victims.

\*File data from both years indicated that out of home placements are extremely rare in cases in which domestic violence is the sole form of identified abuse/neglect.

The Greenbook Project recognizes that national statistics indicate women represent 85-95% of domestic violence victims. The project addresses all adult victims of domestic violence and their abused and neglected children.

In January and May 2005 the cross systems work on this complicated issue continued through the combined efforts of the Domestic Violence Specialist Program and Greenbook. Greenbook staff facilitated discussions between the Domestic Violence Specialists, crisis center directors, NH Coalition staff, and DCYF supervisory staff.

In January the group identified and discussed risk and protective factors in an effort to inform when DCYF intervention is warranted in a family.

In May, utilizing case scenarios, the group identified case assessment information needed and safe mechanisms for collecting information as well as protective and risk factors present in the preliminary assessment with a particular focus on the effects of the domestic violence on the children. A discussion followed as to a safe, beneficial intervention for the family.

### Project Activity Highlights

The Project was well represented by the primary partners and CASA at the National Greenbook All Sites Conference in June in Colorado Springs. New Hampshire had 15 project participants and staff in attendance. Highlights included time for site specific meetings to reflect on the provision of real help to families and the sustainability of the project when funding ends in August 2006. System specific toolbox meetings were, as always, very useful for sharing and learning what is happening across the country. A CD of materials and products developed from all the Greenbook sites to date is available from the Grafton County Greenbook office.

On May 26th Grafton County Family Division iudges met with Grafton **County Batterer** Intervention Program providers at Plymouth District Court. There was dialogue as to the difference between BIP and anger management, assessment procedures, program compliance with the NH State Standards for Batterer Intervention Programs and a description by the providers as to program content and process.

Greenbook Project was proud to host the Project Directors from all the Greenbook sites across the country at the Mt. Washington Hotel for the annual Project Directors meeting in May. Highlights of the meeting included planning for the sustainability of the work of the projects and sharing information and ideas across sites. Grace Mattern. Executive Director of the NH **Coalition Against** Domestic and Sexual Violence, and Bernie Bluhm, Administrator at DCYF, came to talk with the directors about the **Domestic Violence** Specialist Program. The DVS Program in NH is a model for other states that are developing programs for co-located positions in child welfare and domestic violence advocacy.

The Crisis Center Coalition Team is working with Consultant Amy Torchia from the Vermont Network Against Domestic and Sexual Violence to continue work towards the team's goals that focus on enhancing work with children. Ms. Torchia is reviewing shelter intake packets and discussing training needs with crisis center staff. Lonna Davis of the Family Violence Prevention Fund facilitated a discussion in June at a crisis center exploring the implications of beginning a children's program. An advocate

from a crisis center attended training on clinical interventions with children at Boston Medical Center and will be starting a children's group in September in Plymouth. Several advocates from the Greenbook involved crisis centers will be attending training in Sept. at the Vt. Network entitled "From Minor to Major: a Focus on Children and Youth Advocacv in Domestic and Sexual Violence Programs".

### **Resources Available**

The Greenbook Project is always adding to its resource library. Recent book additions include Assessing Women in Battering in Mental Health Services by Edward Gondolf and Helping Your Children Heal the Wounds of Witnessing Abuse by Lundy Bancroft. The following publications from the Family Violence Prevention Fund are also available from Greenbook: Family Team Conferences in Domestic Violence Cases, Guidelines for Practice; Advocacy Matters, Helping Mothers and Their Children; Accountability and Connection with Abusive Men; and Confidentiality & Information Sharing Issues, For Domestic Violence Advocates Working with Child Protection and Juvenile Court Systems.

Attorney Kristin Lamont, Director of the NH Court Improvement Project since 1997, was recently honored with the annual Division for Children, Youth and Families (DCYF) Director's Award. The award was presented by DCYF Director Nancy Rollins at the annual DCYF Conference held May 12- 13, 2005 in Nashua. Kristy was recognized for her efforts to develop, implement and support *Protocols Relative to Child Abuse and Neglect and Permanency Planning.* The Protocols are the result of a three-year multidisciplinary initiative to enhance the court system's response to families involved in child abuse and neglect proceedings. In bestowing the award, Nancy Rollins emphasized Kristy's collaboration with many professionals dedicated to protecting children, stating that Kristy has demonstrated a unique ability to facilitate the development of relationships.

Attorney Gina Apicelli, former Greenbook Project Director and current Family Division Administrator, was honored with the 2005 Honorable William D. Paine, II Award.
